

DECEMBER LEGISLATIVE COORDINATOR'S UPDATE

appy Holidays and Merry Christmas to all A.B.A.T.E. brothers and sisters! As 2024 comes to a close, it is time to reflect and then to look forward As I write this entry, we have a slim chance of seeing two bills moving to Governor Shapiro's desk. Both need a single floor vote during

November lame duck session. HB 2177, Allowing Motorcycles to be Safety Inspected Year-round, Mullins, An Act amending Title 75 (Vehicles) of the Pennsylvania

- Consolidated Statutes, in inspection of vehicles, further providing for inspection of motorcycles. SB155 Extending Lemon Law Protection to Motorcycles, Brooks, An Act amending the act of March 28, 1984 (P.L.150, No.28), known as the Automobile Lemon Law,
- further providing for definitions, for repair obligations, for manufacturer's duty for refund or replacement and for presumption of a reasonable number of attempts. Politics and legislation can be set aside while gathering with family and friends to celebrate but for me that requires some discipline. Elections appear to have handed us another two-

year session with a divided assembly. What the divided government will mean to bikers remains to be seen. It is likely that getting legislation moved through both chambers will continue to be very difficult. The slate has been wiped clean of all the proposed legislation and the process starts all over again for the 2025 – 2026 session. What is known for sure is that our organization must continue to be working to protect the biker lifestyle and the freedom of the road in the Capitol.

Plan on attending the 2025 Leadership and Legislative Seminar next month at the Red Lion Hotel in Harrisburg. In addition to good times with like-minded bikers the event provides a wealth of information about how A.B.A.T.E of PA works.

- 3. Scholarship is open to all four-year degree, two-year associate degree or trade school applicants.
- 4. Selection will be based on leadership and good citizenship and will be judged on the essay provided.

CONDITIONS:

- 1. Must contact A.B.A.T.E. state office at 717-731-8955 to obtain application or go online at abatepa.org to download a copy. Application must be postmarked no later than one week (7 days) prior to the scheduled A.B.A.T.E. of PA Grand Board Meeting in March. Please mail to: A.B.A.T.E. of Pennsylvania, PO Box 619, Shippensburg, PA 17257. Emails or fax's are not acceptable when returning the application.
- 2. Proof of full acceptance and enrollment must be received before scholarship money is awarded (before the check is written to the school, not before scholarship is awarded).
- 3. Applicant must compose and attach a typed essay of 500-750 words on an A.B.A.T.E. related topic. Please do not put your name on the essay. The essay will be assigned a number that corresponds with your application. (You should also email this essay to stateoffice@abatepa.org)
- 4. All applicants agree to allow A.B.A.T.E. of PA to publish his/her essay with photo in our newsletter, Between the Lines. Please include photo for publication.

JUDGING:

- 1. Judging will be completed by a group of five board members (combination of executive board and board of directors)
- 2. Scholarship winners will be chosen at the March A.B.A.T.E. of PA Grand Board Meeting and winners will be notified within 10 days. Public presentation of the scholarship will be completed at the Motorcyclists Rights Rally at the state capitol.

Christmas Salute, the story behind the story...

In November 2008, when I was State Coordinator, writer's block took over and I couldn't come up with a motorcycle related column for the December newsletter. So, I wrote about the first other thing that came to mind, and the first Christmas Salute story was written about the Christmas Truce in 1914. The Salute stories are all true as best I can find out. Researching them is sometimes tough, emotionally. Not all the Christmas Salute material gets written about. Some of the stories I have encountered are not suitable for publishing. But I hope you have enjoyed reading them half as much as I have enjoyed researching and writing them. In what has become a tradition, A.B.A.T.E. of PA is honored to devote a portion of Between The Lines to our service members around the world and their families. This is our Christmas Salute to those who serve. For most of us, Christmas is a time of celebration, gift giving, family, and friends. For many of our service members, that is not always the case. But despite being separated from loved ones, the Christmas spirit survives and flourishes in the most unlikely of places and times. Past Christmas Salutes have taken us as far back as 1776 and as far away as the far side of the moon.

The first Christmas Salute ran in 2008 and was about the 1914 Christmas Truce, among other things. Since then, there has been a Christmas Salute each year except for 2011 and 2012. There have been fourteen Christmas Salutes leading up to this one (number fifteen). We have saluted Conrad Heyer, the only soldier who crossed the Delaware with George Washington on Christmas Eve 1776 whose image exists in a photograph. And we have saluted the Apollo 8 astronauts who took the famous Earthrise photo and read the first ten verses of Genesis to us on live television on Christmas Eve 1968.

This year's Salute is a tribute to the last Christmas of the Civil War, in 1864. In the very first Christmas Salute, I wrote about the 1914 Christmas truce which occurred in the trenches at Ypres, Belgium. But that event was still fifty years in the future. Petersburg, Virginia in 1864 was in its sixth month of besiegement by the Union Army using the relatively new tactic of trench warfare. If Petersburg fell, the city of Richmond would also fall and the Civil War would come to a close. But on Christmas Day 1864, this was not yet a certain outcome. Lee's surrender at Appomattox Court House was still four months in the future.

Lee's Army of Northern Virgina had constructed a massive set of defensive trenches forty miles long. Grant's Army of the Potomac was arrayed along this line and outnumbered the Confederate defenders by three to one but hadn't yet broken through. The Confederate forces were short on supplies and starving. Only one dilapidated railroad line to the south was still available for resupply. The Confederate troops were surviving on four ounces of meat, half a pound of flour, and a little coffee, tobacco, and salt each day. The lines were less than a quarter mile apart, and shots were fired immediately at any soldier unfortunate enough to stick his head out of his trench. This was the beginnings of trench warfare in 1864.

But Sunday December 25th,1864 dawned clear and not too cold. And something unusual was happening the likes of which would not be seen again for another fifty years...two armies would, against orders, stop shooting at each other on Christmas Day.

In the words of E. S. Sanders (who was present as a Confederate soldier) as

published in the Anderson Intelligencer in on December 11, 1901...

"The sun came up and the first day for many months looked upon the armies who were not carrying on the work of death. It seemed as though each had agreed to suspend their deadly efforts for one day. A head could appear for a second or two above the parapet and in full sight of the enemy and not have a dozen minnie balls fired at it. Both sides soon discovered that the orders to fire at an enemy whenever in sight were being disobeyed. The men had suspended their work without being so ordered and in a few minutes they were passing in full sight of each other, shouting the compliments of the season, giving invitations to cross over and take a drink, to come to dinner, to come back into the Union, to come over and get a plug of tobacco and other amenities, which were a singular contrast to the asperities of war. Several times a group of three or four from each side would dash out from the trenches in spite of the commands of the officers and meet midway, have a rapid exchange of drinks, tobacco and other objects. To a visitor ignorant of war it would have appeared incredible that the men thus fraternizing had been trying to kill each other for years."

"I have been informed by several of them who did it, that on the nights of Christmas eve and Christmas the soldiers from both sides fraternized in the picket holes and agreed not to shoot during Christmas and tried to reach an agreement by which they would not endeavor to kill each other when momentarily exposed above the parapet... many visits were made on that day, and friends from the same community in distant States, who had been long separated saw each other, some for the last time. To the entire army, as I was informed, it was a day of cheer, one bright spot

in the gloom of present distress and impending defeat."

Perhaps for the first time in the history of warfare, fifty years before that more famous day in 1914, the guns of two armies fell silent on Christmas Day, with no orders to do so beyond the spirit of the men whose weapons did not fire that day. And so it came to pass that Christmas arrived even to a place in hell called Petersburg, Virginia on December 25, 1864.

And now we conclude, as we do every Christmas Salute, with these words...

For many members of our armed forces, Christmas is a day spent in a place you'd rather not be...a long way from home and family. For the rest of us, the holidays are a time to remember those who serve and their families and be grateful for their sacrifice.

From all the members of A.B.A.T.E. of PA, our heartfelt thoughts go out to the members of our armed services this holiday season, their families who are without them, and our prayers for their speedy and safe return.





reetings from your Office Manager! I hope everyone is doing well and gearing up for the winter months ahead. I wish you and yours a very happy holiday season and hope that maybe we will get a nice day or two to take the bikes out for a cruise.

I have been working with Katherine Pratt and our new American Income Life contact, Travis Daniels, to address the repeated phone calls and some other questions about our Accidental Death & Dismemberment benefit.

QUESTIONS AND ANSWERS ARE BELOW.

Please feel free to call me with any other questions you may have.

A few things to keep in mind:

- 1. To stop the calls, don't return the beneficiary card.
- 2. This IS NOT life insurance it is accidental death and dismemberment benefit.
- 3. The accident does not have to be strictly motorcyclerelated. It can be any type of accident as in motorcycle, truck, auto, house fire, etc.
- 4. The dismemberment benefit DOES NOT pay out the same amount as the accidental death benefit of \$3000.00. Dismemberment benefit may be \$1500.00.
- 5. To file for the accidental death benefit, send a copy of the death certificate to the state office by mail or email. To file for the dismemberment benefit, call the office to find out what documents you and your doctor will need to complete.
- 6. Benefits apply to junior members too.

Must be a member in good standing at the time of death/ accident in order to file for and claim the accidental death or dismemberment benefit.

A.B.A.T.E - What can we do to stop the demanding, repeated phone calls and ensure members get their Certificates of Insurance?

AIL - Regarding the demanding phone calls, I will definitely work on inspecting our contact history to ensure that we are working to service the members effectively and as minimally invasive as possible, with respect to their wishes if they request not to be contacted. I can certainly help provide any member that wish a certificate of insurance.

A.B.A.T.E. - I am told that if the orange beneficiary cards are returned, this is what prompts the phone calls. Is this true?

AIL - When a member returns the beneficiary card, yes, that prompts us to reach out to the member. We are under the impression that they read the member benefit notification and are requesting additional information about American Income Life and also the additional nocost benefits (AIL Plus Health Services Discount Card, Child Safe Kits, Will Kit/Memorial Guide). Through the interest in our additional, affordable permanent life insurance products; we are able to continue to support the no-cost benefits and the accidental death and dismemberment coverage paid to members at no cost.

A.B.A.T.E. - Members have this no-cost coverage even if they do not return the beneficiary card. Is this true?

AIL - Every member has the no-cost additional death and dismemberment coverage regardless of if they return the beneficiary card.

A.B.A.T.E. - A lot have reported repeated phone calls with the AIL representative stating that they must meet face to face to speak with the member, either in person or on Facetime. Most older members don't have Facetime. The member says they do not want any extra insurance and the representative still states that they must meet with the member even if that is the case. Is this true?

AIL - Members DO NOT have to meet with a representative. If any member is struggling with calls after they have requested not to be contacted, I want to get involved and

get this reported and investigated. Every member has the no-cost accidental death and dismemberment coverage regardless of if they meet with a representative.

A.B.A.T.E. - Members have requested a Certificate of Insurance showing that they have this \$3,000.00 AD & D coverage and are being denied the COI unless they meet with a representative. We are finding that family members of the accidental death victim know nothing of this benefit and that having a COI available with their other important papers would be very helpful. I was informed that all that needed to happen was, when contacted, the member should politely decline the extra insurance and request a COI and then it would be mailed to the member upon request – to my knowledge to date-that has not happened.

AIL - A certificate can certainly be requested. With our representatives working remotely, it makes it very easy to email or mail it over to the member. If that is not occurring, I will ensure that I discuss with our offices to reiterate the importance of following through with the member's request. If any member wants a COI immediately, doesn't want to talk to a representative or does not want to send back the card, we/myself can prepare and mail/email it over to them.

A.B.A.T.E. - Please explain the \$2.00 additional AD & D benefit option we have heard about.

AIL - We are offering \$10,000.00 of additional AD & D insurance for \$2.00 for the first year (12 months) of coverage. Each year after - the coverage can be renewed for only \$5.00. Additional coverage can be requested using the enclosed Additional Coverage Application form. Member can mail the form with their \$2.00 payment (check preferably for their records) to American Income Life Insurance Company P.O. Box 2608, Waco, Texas 76797 . Our headquarters will then mail them a certificate of coverage for the additional \$10,000.00.



POOL TOURNAMENT RULES

CHAPTER, DISTRICT AND STATE

tate Pool Tournament will be held on a Saturday February 8, 2025, at the American Legion, Smith-Pletcher Post 779 at 2928 Penns Valley Pike, Centre Hall, PA 16828 (south side of Route 144, just east of the intersection of Route 45 and Route 144 (same place as our State Board Meetings are). Doors open at 10:00 am, registration starts at 10:30 am. Tournament starts at noon.

Listing of Winners of the district pool tournaments must be in the state office no later than February 1, 2025.

RULES ARE AS FOLLOWS:

- Must be a member of their Chapter for one (1) month to be eligible to play in the Chapter, District and State Tournaments.
- There should be five players from each chapter to go to the district pool tournament and five players from each district to go to the state tournament. There will be three trophies awarded at the state pool tournament 1st, 2nd, and 3rd.

The following are the Billiard Congress of America rules for eight (8) ball:

- 1. Object of the Game Eight Ball is a call shot game played with a cue ball and fifteen object balls, numbered 1 through 15. One player must pocket balls of the group numbered 1 through 7 (solid colors) while the other player has 9 through 15 (stripes). The player pocketing his group first and then legally pocketing the 8-ball wins the game.
- 2. Call Shot In Call Shot, obvious balls and pockets do not have to be indicated. It is the opponent's right to ask which ball and pocket if he is unsure to the shot. Banks and combinations are not considered obvious and both the object ball and the pocket must be called. When calling the shot, it is NEVER necessary to indicate details such as the number of cushions, banks, kisses, caroms, etc. Any balls pocketed on a foul remain pocketed, regardless of whether they belong to the shooter or the opponent. The opening break is not a "called shot". Any player performing a break shot in 8-Ball may continue to shoot his next shot as long as he has legally pocketed any object on the break.
- 3. Racking the Balls The balls are racked in a triangle at the foot of the table with the 8-ball in the center of the triangle, the first ball of the rack on the foot spot, a stripe ball in one corner of the rack and a solid ball in the other corner.
- 4. Alternating Break Winner of the lag has the option to break. During individual competition, players will alternate breaking on each subsequent game.
- 5. Legal Break Shot (Defined) To execute a legal break, the breaker (with the cue ball behind the headstrong) must either (1) pocket a ball, or (2) drive at least four numbered balls to the rail. If he fails to make a legal break, it is a foul, and the incoming players has the option of (1) accepting the table in position and shooting, or (2) having the balls reracked and having the option to shoot the opening break himself. It is not necessary to hit the apex ball (the ball that is on the foot spot) to initiate a legal break in Eight Ball.
- 6. Scratch on a Legal Break If a player scratches on a legal break shot, 1) all balls pocketed remain pocketed (exception, the 8-ball, see Rule 6) 2) it is a foul 3) the table is open. Please note: Incoming player has cue ball in hand behind the head string and may not shoot an object ball that is behind the head string, unless he first shoots the cue ball past the head string and causes the cue ball to come back behind the head string and hit the object ball.
- 7. 8-Ball Pocketed on the Break If the 8-ball is pocketed on the break, the breaker may ask for a re-rack or have the 8-ball spotted and continue shooting. If the breaker scratches while pocketing the 8-ball on the break, the incoming player has the option of re-rack or having the 8-ball spotted and begin shooting with ball in hand behind the head string.
- 8. Open Table (Defined) The table is "open" when the choice of groups (stripes or solids) has not yet been determined. When the table is open, it is legal to hit a solid first to make a stripe or vise-versa. Note: The table is always open immediately

- after the break shot. When the table is open it is legal to hit any solid or stripe or the 8-ball first in the process of pocketing the called stripe or solid. On an open table, all illegally pocketed balls remain pocketed.
- 9. Choice of Group The choice of stripes or solids is not determined on the break even if balls are made from only one or both groups. The table is always open immediately after the break shot. The choice of group is determined only when a player legally pockets a called object ball after the break shot.
- 10. Legal Shot A player must cause the cue ball to contact a legal object ball (i.e. any ball of that shooters numbers and then: a) pocket a numbered ball, of that shooters series, b) cause the cue ball or any numbered ball of that shooter to contact a cushion or any part of the rail. Failure to meet these requirements is a foul.
- 11. Safety Shot For tactical reasons a player may choose to pocket an obvious ball and also discontinue his turn at the table by declaring "safety" in advance. A safety shot is defined as a legal shot. If the shooting player intends to play safe by pocketing an obvious object ball, then prior to the shot, he must declare a "safety" to his opponent. If this is NOT done, and one of the shooter's object balls is pocketed, the shooter will be required to shoot again. Any ball pocketed on a safety shot remains pocketed.
- 12. Scoring A player is entitled to continue shooting until he fails to legally pocket a ball of his group. After a player has legally pocketed all of his group of balls, he shoots the pocket the 8-ball.
- 13. Foul Penalty Opposing player gets cue ball in hand. This means that the player can place the cue ball anywhere on the table (does not have to be behind the head string except on opening break). This rule prevents a player from making intentional fouls, which would put his opponent at a disadvantage. With "cue ball in hand" the player may position the cue ball on the table by hand (more than once if necessary). After placing the cue ball, the shaft and ferrule of the cue stick (not the tip) may also be used for positioning the cue ball for shooting.
- 14. Combination Shots Combinations shots are allowed, however, the 8 ball or opponent's ball cannot be used first in the combination except when the table is open.
- 15. Illegally Pocketed Balls An object ball is considered to be illegally pocketed when 1) that object ball is pocketed on the same shot as a foul is committed, or 2) the called ball did not go in the designated pocket, or 3) a safety is called prior to the shot. Illegally pocketed balls remained pocketed.
- 16. Object Balls Jumped Off the Table If any object ball is jumped off the table, it is a foul and loss of turn, unless it is the 80ball, which is a loss of game. Any jumped object balls are spotted in numerical order according to General Rules for spotting balls.
- 17. Playing the 8-Ball When shooting at the 8-ball, a scratch or foul is not loss of game if the 8-ball is not pocketed or jumped from the table. Incoming player has cue ball in hand.
- 18. Loss of Game A player loses the game if he commits any of the following infractions; a) Fouls when pocketing the 8-ball (exception: see 8-ball pocketed on the break) b) Pockets the 8-ball on the same stroke as the last of his group of balls c) Jumps the 8-ball off the table at any time d) Pockets the 8-ball in a pocket other than the one designated. 3) pockets the 8-ball when it is not the legal object ball.
- 19. Stalemated Game If in 3 consecutive turns at the table by each player (6 turns total) they purposely foul or scratch and both players agree that attempting to pocket or move an object ball will result in immediate loss of game, then the game will be considered a stalemate. The balls will then be re-racked and the breaker of the stalemated game will break again. Please note: three consecutive fouls by one player is not a loss of game.

RAFFLE TICKET PRINTING REQUIREMENTS

Raffles are a great way to raise money for our chapters. In order to have a raffle there are some rules and requirements that must be followed to make it a legal raffle. Over the years, there have been a lot of raffle tickets, posted on social media or sold at functions, across the state, that do not follow the requirements of your Small Games of Chance (SGOC) license.

You may think that your chapter will not get busted for not following the requirements, but it may just be a matter of time until you do! I have seen and heard about organizations getting nailed for holding illegal raffles. It only takes one disgruntled member to make 'that' phone call. Lately, it seems that Enforcement officers have nothing better to do but to police social media, looking for organizations to bust!! With events, across the state, and chapters posting their events, I thought this would be an appropriate article to write.

In order to hold a legal raffle, The following requirements need to take place:

- ◆ Having or applying for a Small Games of Chance License for your chapter and displaying it at the raffle drawing and having it on hand if questioned during ticket sales.
- Figure out are the logistics to having the raffle.
- Printing of the raffle tickets. There are requirements that must be followed to make it legal.

The following diagram is what the Pennsylvania State Police and Bureau of Liquor Control Enforcement require when printing raffle tickets.

Raffle Ticket Printing Requirements: The minimum information MUST be printed upon each raffle ticket sold:



- 1. The **dates** and **time** of the drawing 2. The location of the drawing.
- 3. The name of the licensed eligible organization conducting the raffle.
- 4. The Small Games of Chance license number of the licensed eligible organization.
- 5. The special raffle permit number, if applicable
- 6. The cost of the ticket.
- 7. The prize or prizes to be awarded.
- 8. The ticket must be sequentially numbered & have a detachable stub with same number.
- 9. The stub must contain the purchaser's name, address & phone number.

Other requirements are:

- * There **MUST** be a winner in a raffle.
- * Cannot award alcohol as a prize.
- * Drawing must be conducted in plain view of players present.
- * Use of state lottery number is permissible. Only when ticket sales equal the total possible numbers. (E.G. 1000 tickets must be sold to utilize the daily number).

- 3. Applicant must compose and attach a typed essay of 500-750 words on an A.B.A.T.E. related topic. Please do not put your name on the essay. The essay will be assigned a number that corresponds with your application. (You should also email this essay to stateoffice@abatepa.org)
- 4. All applicants agree to allow A.B.A.T.E. of PA to publish his/her essay with a photo in our newsletter, Between the Lines. Please include a photo for publication.

JUDGING:

- 1. Judging will be completed by a group of five board members (combination of executive board and board of directors)
- 2. Scholarship winners will be chosen at the March A.B.A.T.E. of PA Grand Board Meeting and winners will be notified within 10 days. Public presentation of the scholarship will be completed at the Motorcyclists Rights Rally at the state capitol.
