

HAPPY NEW YEAR FROM YOUR LEGISLATIVE COORDINATOR

024 will be in the rear-view mirror and I am optimistic for what 2025-26 Legislative session will provide.

The November 5th election results were a big change on the Federal level while the Commonwealth remains nearly the same as last session.

Divided Legislature is what we must work with and it's up to us to make it known that motorcycles are non-partisan. Bikers occupy that "common ground" that can bring both sides together.

2023-24 LEGISLATIVE REVIEW

In Harrisburg the two-year Assembly session came to an end on November 13th, 2024. On that last day A.B.A.T.E. of PA came through with two wins specifically for motorcycles. The final votes were unopposed in both Senate and House.

- Act 149 removes the section of title 75 that prohibited motorcycle inspections in November, December, January and February. Makes motorcycles same as other vehicles.
- Act 151 Includes motorcycles in the Lemon Law that has protected cagers buying a new car since the early 1980s. Motorcycles were intentionally excluded. A.B.A.T.E. of PA has lobbied to correct this unfair treatment of motorcycles since 1996. Now it is finally corrected. Thanks to all that worked on this. Sorry I'm going to miss someone, Senator Michelle Brooks, Representative (now Senator) Nick Pisciottano, Chairman Robert Matzie and former Representative Pam Snyder.

This result was because of persistence. Members making Senators and Representatives see us in the district. Day after day being in the halls at the Capitol leaving behind reminders in their offices and asking repeatedly for what is fair and right at the right time and place.

HOW IT GETS DONE

Charles Umbenhauer shined the light in the flier titled Keys to Success a few years ago. Truer today than it was then three main components are needed to get results.

- 1. A Proven Lobbying Team: With Archer Public Affairs and our presence in Harrisburg it is clear that A.B.A.T.E. of PA is here for Bikers and is not going away.
- 2. An Effective Grassroots: Members in the district delivering our message and developing relationships with Lawmakers is essential. Senators and Representatives

- that know you ride, and you vote will make an impact, more than you might think.
- 3. A Healthy PAC Fund: Quoting Charles Umbenhauer, "Some argue that PAC funds are a necessary evil. Well, that's only half right. They are not evil, but they are absolutely necessary."

Because of the dedication to the lifestyle and commitment of your treasure Bike PAC has had the funds to put your team in the right places at the right time in Harrisburg and in the districts.



2025-26 LOOK AHEAD

- 1. PAMSP Improved Attendance: A.B.A.T.E. will re-introduce legislation to keep PAMSP rider training free to all students while asking for a deposit, fully refundable upon attending training. Some skin in the game could be expected to reduce student no-shows improving more riders' skills.
- 2. Lifestyle/Profiling: Codifying that it is not a primary offense that you ride a motorcycle. Choice of transportation, or what you wear should not be the reason for traffic stops.
- 3. Engine Choice/Right to Repair: Riding your ride is at the center of the lifestyle. Having the ability to service and repair your bike should be your choice and not the Government or the manufacturers. Regulations to eliminate Internal Combustion Engines will be opposed.
- 4. **Highly Automated Vehicles:** This technology is here now. A.B.A.T.E. will work to include motorcycles in the "view" of the robots that will be controlling these cars and trucks.

L&L later this month there will be a session to sharpen the edge on what our 2025-26 focus will be. If you are a stakeholder, make it known what is important to you.

MRF UPDATE

THE AFTER-EFFECTS OF THE ELECTION

n October 7, 2023, the California Air Resource Board (CARB) announced it would conduct a public hearing to consider approving for adoption the proposed amendment to emission standards, testing procedures and the adoption of new provisions relating to on-road motorcycles.

Not much later on November 7, 2023, the hearing was postponed shortly before it was scheduled to begin and no new date was given. Remember, Pennsylvania is a CARB compliant state. What is enacted there will make its way here.

Surprisingly on December 6, the California Air Resource Board (CARB) announced they would not be proceeding with proposed standards requiring half of all new motorcycles sold in the state be electric within the next decade. In a statement, CARB said "The proposed amendments to on- Road motorcycles (ONMC) emission standards, and test procedures and adoption of new provisions relating to ONMC's have been withdrawn. This is great news, but we have to be very cautious because CARB reserves the right to adjust, amend, and resubmit plans like this in the future. We have to be vigilant and keep an eye on our freedom.

On November 13, 2024, Senate Republicans elected Senator John Thume of South Dakota as the new Senate Majority Leader. In 2018 Senator John Thune was named the MRF Legislative Champion of the Year.

Later in November 2024, President-elect Donald Trump named former Congressman Sean Duffy as his nominee for the US Secretary of Transportation. Before resigning his seat in 2019, Representative Duffy was elected five times to represent the seventh congressional district of Wisconsin. Abate of Wisconsin feels Congressman Duffy will work with Motorcyclists.

Let's welcome two new members who joined at the meeting; Hunter Forsythe and Shawn Harris. If you see them say thanks and welcome to the fold.



LOSING HALF OF NEW MEMBERS?

uring the 11/16 State Board Meeting at Centre Hall, Brian Magness (State Membership Officer) shared that A.B.A.T.E. of PA has a 47% loss of its first-year members! While we all work hard to gain new members, we lose half the first year!

Without documenting the "Why" by surveying the non-renewals, we can suspect it is often likely to be: "Didn't feel welcome" or "Didn't get to know other members" or "Didn't make meetings" or "Thought it was about riding" etc.

Simple 3-point approach based upon what successful organizations do for retention can be:

- 1. WHY Understanding WHY individuals did not renew can only be learned with a follow-up communication. That is best accomplished by direct contact face to face or at least a phone call. The "why" helps us understand how we fell short and represents an opportunity for improvement by making changes. It also is a reminder to the individual that someone cares enough to follow up. Often that contact alone causes the person to renew anyhow.
- 2. MENTOR Each "new member" benefits from a designated "mentor" for the first year. The mentor (advisor, guide, teacher, counselor) would maintain regular contact with the new member during the first 12 months. The concept is for a new member begins to feel they belong, they make new friends, and a sense of belonging helps create good value to the member to renew. A regular phone call or e-mail is made by the mentor to a new member with invitational topics such as:
 - "Are you going to make the meeting on _____? Why don't we ride-in/drive together?"
 - "A couple of us are taking a ride to _____. How about coming along?"
 - " dealership is having a group ride or a show. Want to go together?"
- 3. INVOLVEMENT Successful retention organizations often have a special committee or group that new members are assigned into. Included are a couple experienced members in charge of the new member group. The group is involved in things like setting up the room for meetings, selling 50/50s at meetings, doing mailings, posting ride signs, erecting A.B.A.T.E. roadside signs ...just basic tasks. That gets them involved, ensures contact with other existing and new members to create new friends and a sense of belonging.

Ideally each chapter should track their loss of first year members. Measurement alone makes it important, and those in charge will pay more attention toward improvement. Bottom line is: "How is your chapter doing at retaining new members?"





KENNETH UBRY | DECEMBER 1950-AUGUST 2021

First and foremost, Kenny was a motorcycle enthusiast. From an Allstate Moped to a BMW RT 1400, with a multitude of other bikes between the two. Born, raised & resided in western PA. He never stopped riding, if the roads were clear, he would be on the bike. He had a four-wheel vehicle, he preferred two wheels. There were usually at least two bikes in the garage, and at times as many as six, often changing out one or two every couple of months. All maintenance was completed by Kenny, with exception of mounting tires, and he went through a lot of tires!

Kenny rode, A LOT! To go out with Kenny for a ride you would need to clear your schedule for the morning or afternoon, and often both as the ride would progress. Two-to-three-hundred-mile days were normal scoots. Take a short break for a soda & candy bar and mount up again. Don't waste daylight, and get home before the deer come out.

Kenny knew more routes to get to Warren, PA than anyone. September and October were his favorite months to be out "catching leaves." West Virginia was a favorite place to spend several days for extended fine riding.

Among some of his riding milestones:

- 1. Iron Butt 1,000-mile day award.
- 2. Route 62 from New York to Texas. Full length.
- 3. 2020 National BMW Rally in Montana.
- 4. High mileage year award from BMW owners club for the year 2020; 24,000 miles. Kenny was a unique and special person, very independent, extremely trustworthy, and loyal. He was able to enjoy conversation with anyone he met, at anytime and any place. If he was asked to be somewhere to help someone you could count on him to be there. He had a host of friends spread over the countryside, both riders and non riders.

When he was on the bike he was one with the ONE. The night he was called home he was on the bike returning to New Castle, PA following an evening helping a group of friends. The two most important things in his life!

Greatly loved and missed by the families of his sister Kathleen Shoaf, and brothers, Paul, and Bruce Ubry.



POOL TOURNAMENT RULES

CHAPTER, DISTRICT AND STATE

tate Pool Tournament will be held on a Saturday February 8, 2025, at the American Legion, Smith-Pletcher Post 779 at 2928 Penns Valley Pike, Centre Hall, PA 16828 (south side of Route 144, just east of the intersection of Route 45 and Route 144 (same place as our State Board Meetings are). Doors open at 10:00 am, registration starts at 10:30 am. Tournament starts at noon.

Listing of Winners of the district pool tournaments must be in the state office no later than February 1, 2025.

RULES ARE AS FOLLOWS:

- Must be a member of their Chapter for one (1) month to be eligible to play in the Chapter, District and State Tournaments.
- There should be five players from each chapter to go to the district pool tournament and five players from each district to go to the state tournament. There will be three trophies awarded at the state pool tournament 1st, 2nd, and 3rd.

The following are the Billiard Congress of America rules for eight (8) ball:

- 1. Object of the Game Eight Ball is a call shot game played with a cue ball and fifteen object balls, numbered 1 through 15. One player must pocket balls of the group numbered 1 through 7 (solid colors) while the other player has 9 through 15 (stripes). The player pocketing his group first and then legally pocketing the 8-ball wins the game.
- 2. Call Shot In Call Shot, obvious balls and pockets do not have to be indicated. It is the opponent's right to ask which ball and pocket if he is unsure to the shot. Banks and combinations are not considered obvious and both the object ball and the pocket must be called. When calling the shot, it is NEVER necessary to indicate details such as the number of cushions, banks, kisses, caroms, etc. Any balls pocketed on a foul remain pocketed, regardless of whether they belong to the shooter or the opponent. The opening break is not a "called shot". Any player performing a break shot in 8-Ball may continue to shoot his next shot as long as he has legally pocketed any object on the break.
- 3. Racking the Balls The balls are racked in a triangle at the foot of the table with the 8-ball in the center of the triangle, the first ball of the rack on the foot spot, a stripe ball in one corner of the rack and a solid ball in the other corner.
- 4. Alternating Break Winner of the lag has the option to break. During individual competition, players will alternate breaking on each subsequent game.
- 5. Legal Break Shot (Defined) To execute a legal break, the breaker (with the cue ball behind the headstrong) must either (1) pocket a ball, or (2) drive at least four numbered balls to the rail. If he fails to make a legal break, it is a foul, and the incoming players has the option of (1) accepting the table in position and shooting, or (2) having the balls reracked and having the option to shoot the opening break himself. It is not necessary to hit the apex ball (the ball that is on the foot spot) to initiate a legal break in Eight Ball.
- 6. Scratch on a Legal Break If a player scratches on a legal break shot, 1) all balls pocketed remain pocketed (exception, the 8-ball, see Rule 6) 2) it is a foul 3) the table is open. Please note: Incoming player has cue ball in hand behind the head string and may not shoot an object ball that is behind the head string, unless he first shoots the cue ball past the head string and causes the cue ball to come back behind the head string and hit the object ball.
- 7. 8-Ball Pocketed on the Break If the 8-ball is pocketed on the break, the breaker may ask for a re-rack or have the 8-ball spotted and continue shooting. If the breaker scratches while pocketing the 8-ball on the break, the incoming player has the option of re-rack or having the 8-ball spotted and begin shooting with ball in hand behind the head string.
- 8. Open Table (Defined) The table is "open" when the choice of groups (stripes or solids) has not yet been determined. When the table is open, it is legal to hit a solid first to make a stripe or vise-versa. Note: The table is always open immediately

- after the break shot. When the table is open it is legal to hit any solid or stripe or the 8-ball first in the process of pocketing the called stripe or solid. On an open table, all illegally pocketed balls remain pocketed.
- 9. Choice of Group The choice of stripes or solids is not determined on the break even if balls are made from only one or both groups. The table is always open immediately after the break shot. The choice of group is determined only when a player legally pockets a called object ball after the break shot.
- 10. Legal Shot A player must cause the cue ball to contact a legal object ball (i.e. any ball of that shooters numbers and then: a) pocket a numbered ball, of that shooters series, b) cause the cue ball or any numbered ball of that shooter to contact a cushion or any part of the rail. Failure to meet these requirements is a foul.
- 11. Safety Shot For tactical reasons a player may choose to pocket an obvious ball and also discontinue his turn at the table by declaring "safety" in advance. A safety shot is defined as a legal shot. If the shooting player intends to play safe by pocketing an obvious object ball, then prior to the shot, he must declare a "safety" to his opponent. If this is NOT done, and one of the shooter's object balls is pocketed, the shooter will be required to shoot again. Any ball pocketed on a safety shot remains pocketed.
- 12. Scoring A player is entitled to continue shooting until he fails to legally pocket a ball of his group. After a player has legally pocketed all of his group of balls, he shoots the pocket the 8-ball.
- 13. Foul Penalty Opposing player gets cue ball in hand. This means that the player can place the cue ball anywhere on the table (does not have to be behind the head string except on opening break). This rule prevents a player from making intentional fouls, which would put his opponent at a disadvantage. With "cue ball in hand" the player may position the cue ball on the table by hand (more than once if necessary). After placing the cue ball, the shaft and ferrule of the cue stick (not the tip) may also be used for positioning the cue ball for shooting.
- 14. Combination Shots Combinations shots are allowed, however, the 8 ball or opponent's ball cannot be used first in the combination except when the table is open.
- 15. Illegally Pocketed Balls An object ball is considered to be illegally pocketed when 1) that object ball is pocketed on the same shot as a foul is committed, or 2) the called ball did not go in the designated pocket, or 3) a safety is called prior to the shot. Illegally pocketed balls remained pocketed.
- 16. Object Balls Jumped Off the Table If any object ball is jumped off the table, it is a foul and loss of turn, unless it is the 80ball, which is a loss of game. Any jumped object balls are spotted in numerical order according to General Rules for spotting balls.
- 17. Playing the 8-Ball When shooting at the 8-ball, a scratch or foul is not loss of game if the 8-ball is not pocketed or jumped from the table. Incoming player has cue ball in hand.
- 18. Loss of Game A player loses the game if he commits any of the following infractions; a) Fouls when pocketing the 8-ball (exception: see 8-ball pocketed on the break) b) Pockets the 8-ball on the same stroke as the last of his group of balls c) Jumps the 8-ball off the table at any time d) Pockets the 8-ball in a pocket other than the one designated. 3) pockets the 8-ball when it is not the legal object ball.
- 19. Stalemated Game If in 3 consecutive turns at the table by each player (6 turns total) they purposely foul or scratch and both players agree that attempting to pocket or move an object ball will result in immediate loss of game, then the game will be considered a stalemate. The balls will then be re-racked and the breaker of the stalemated game will break again. Please note: three consecutive fouls by one player is not a loss of game.

Drew Harmon made a motion to approve the September Grand Board meeting minutes as written, the motion was seconded by Jeff Mohney. Motion approved.

State Treasurer – Amy presented the September and October treasurer reports for consideration. Duane Eagan made a motion to approve both reports. The motion was seconded by Tobey Wingard. Motion passed. She reviewed the bi-monthly breakdown, showing that in both months A.B.A.T.E. operated in a deficit. Amy presented the list of delinquent treasurer reports and reported that Luzerne and Lawrence will be given 72 hours to get reports turned in. Otherwise, she will send the fine letters to the chapters.

Legislative Coordinator – Ken informed the Board that a new Assistant State Legislative Coordinator will need to be appointed. He thanked the Board of Directors, Officers and members for all their hard work in their districts as the 2023-24 Legislative session ended Wednesday this past week with SB155 Lemon Law and added amendment HB2177 allowing year-round motorcycle inspections being passed. The Board of Directors and all attending gave Ken a round of applause and standing ovation for a job well done. Ken is already focused on the next session: HAV interface and future development, profiling that was dropped in 2017 and procession bills.

State Products – Tiffany had an excused absence from today's meeting but provided a written report for the Board.

Membership Officer –There are 5,196 members statewide. Brian briefly reviewed the reports provided to the Board and asked that everyone

keep up the good work as our membership numbers continue to grow. He reminded everyone that elected and appointed officer information should be gathered when election results are announced and sent to membership@ abatepa.org.

Public Relations – Sonnie asks that chapters get group pictures of incoming officers and email to her. The deadline is January 30th.

Communications Director – Dominic asks that any new offices request their Microsoft 365 account on the website under officers and resources, office 365 email.

All abatepa.org users need to be accessing their email/teams/office weekly.

Operation Save a Life – Bob shared a record number of 1,639 students have received the OSAL workshop in the first semester of school being in session. He thanked all the chapters doing these presentations. Indiana has reached out to their County Traffic Safety Center with success. The centers will work with you to help you get in to all area schools. Bob also thanked everyone for reaching out when he lost his son to a distracted driver.

Office Manager – Stacey has OSAL brochures for the chapters that need them. Just give her a call!

District Representatives also need to send their information to her as well. She appreciates all the pictures, articles and chapter updates. Thank you.

Sergeant-at-Arms – This is Tiny's last meeting as the State's Master Sergeant-at-Arms. He thanked the Board of Directors for the opportunity to serve. He also gave the State Sergeant-at-Arms the opportunity to introduce themselves to the Board.

OLD BUSINESS:

Motorcycle Riders Foundation Update / NCOM Report - Andy Kelly reports that on Oct. 7 the California air resource board (CARB) announced it would conduct a public hearing to consider approving for adoption of the proposed amendment to on road motorcycles emission standards and testing procedures and adoption of new provisions relating to on road motorcycles. Surprisingly on Nov. 7 the hearing was postponed just shortly before it began. Then Nov 13 the Senate Republicans elected Senator John Thume from South Dakota to be new Senate Majority Leader. In 2018 Senator Thune was named the Legislative Champion of the Year by MRF.

Standing Operations Committee – Scott Minich spoke about trademarks. Federal


trademark fees are \$1850 per trademark every 3 years. In the early 2000's ABATE paid someone who helped maintain our trademarks \$300 annually. None of our trademarks are protected currently. Hazen and OSAL are marked as contested. Scott has an email link for information to trademark chapter and district logos. Brian will send an email with the link to all chapter coordinators for their consideration. Ken spoke about the US patent office and Department of State information. Walter made a motion to retrademark the state emblem, Hazen and OSAL logo regardless of cost. Lenny seconded the motion. Discussion included Tom suggesting that we change the OSAL logo and Hazen logo to include the A.B.A.T.E. of PA logo. Andy is willing to contact the MRF to see how they went about it. Ken suggested doing this in stages. Tiny reminded the Board that the Hazen logo changes annually and there isn't a standard logo. John Pascai suggested that we reach out to companies that will help nonprofits with filing these. Motion failed.

Hazen Committee Report – Hazen 2025 is June 20th – 22nd, NOT Father's Day weekend. The committee is still planning the changes at the gate to make entry faster. They are also working on Starlink and repeaters to be available on the grounds so that ATM machines may be available.

Financial Sustainability Committee Report – John Pascai has three people signed up to serve on this committee. Please reach out to your members. We need knowledgeable members to serve on this committee to plan our financial sustainability for our future. He is hoping to have at least one person per district to serve.

State Newsletter Committee Report - Tom Detrick reports that approximately 800 members receive electronic newsletters. That saved approximately \$300 in postage monthly. The monthly cost of postage is \$2.748.43. Sonnie is going to put something in BTL to encourage the use of electronic version.

Tom presented that the reported cost for the newsletter in November 2024 was \$6,250.85. That's an annual cost of approximately \$75,000. He suggests that the Board consider an increase in Gold and Platinum supporters by \$25 each. The last increase was 2016. We now offer an electronic version AND an interactive map on our website that shows their name and location as an A.B.A.T.E. of PA supporter. They are getting more advertising and acknowledgement for the same amount of money. Advertising needs reviewed and adjusted to yield a better product. Offer a discount for yearly members that select the electronic newsletter. He suggests a \$5 reduction in membership fee. Annually advertise that Life Members register for their copy of the

Customer Relations Management (CRM)/ Membership Management Committee

Report - Dominic Pirocchi reports that the committee is doing a live demo of a version. They are mapping fields from old to new versions during this test. They have 60 days to evaluate this software. They plan on presenting their committee recommendations to the Board at the January meeting.

L&L Update – Ken reports that the weekly planning meetings for this important event continue. He asked again for panel discussion questions related to lifestyle, engine choice, PAMSP and highly automated vehicles to be sent to him by 1/10/2025. He urged District Reps to encourage Chapter Coordinators to use the packets given to them at the Sept. Grand Board meeting to help them stay on track with the deadlines for requested information/participation. BikePAC is making a T-shirt quilt. Sonnie has put out an email and Facebook blast asking for the chapters to send their T-shirts. She also reminded everyone of the deadline of 12/31 for chapter highlights to be submitted.

Proposed 2025 Budget – Amy opened the floor to the Board to adjust the proposed budget. No recommendations were made. The budget will be voted on at the January meeting.

He is done trying to get this idea implemented and will offer all of his gathered information if someone else wants to try again. Eric asked the Board if any District Representative was interested in taking on this project. With no response, this will be removed from future old business and the "hold of designated income" for \$500 for the design of these plates will be removed.




